## **Recommendations / Letter**

Allen explained he has had numerous discussions with County staff and stakeholders within and beyond this group, all the while doing his best to channel the interests and concerns of this group. The County was understandably concerned about the ability to apply any new proposed code/policy concepts on a consistent, fair, and enforceable basis.

We reviewed, edited, and approved by consensus the draft policy recommendations, taking into consideration the interests of stakeholders participating in this group along with the position papers received by Western Washington Agricultural Association, Skagit County Farm Bureau, the Agricultural Advisory Board and Skagitonians to Preserve Farmland. To the greatest extent possible, the proposed recommendations refer to existing code as much as possible where relevant. Approved recommendations included:

- Definitions: Adding new proposed definitions for *Agritourism* and *Farm Event Venues* to SCC 14.04.020and amending existing definitions *Agricultural Support Services* and *Farm-based Business* definitions.
- Recommending the inclusion of Agritourism as an Agricultural Accessory Use subject to rigorous criteria.
- *Recommend establishing a new Limited Entry Permit with a cap on total number of permits available for Farm Venues* that is subject to renewal.
- Established criteria under Permitted Uses for a *Farm Event Venue* that is focused on education directly tied to agricultural production.
- Proposed criteria for an Administrative Special Use Permit and Hearing Examiner Special Use for *Farm Event Venues*.

For the accompanying letter, we left the text as edited at the last meeting and added Skagit Valley Wedding Rentals to the list of supporting organizations.
