### MAKE A ONE-TIME GIFT

### **BECOME A SUBSCRIBING MEMBER**

Spreading your gift out over time is an easy way to support Skagit agriculture. Set up your donation once through our online donation page and the payment will be processed monthly without you having to do anything until you either cancel or change your gift.

### DONATE VIA AN IRA QUALIFIED CHARITABLE DISTRIBUTION

When planning your IRA withdrawal strategy, if you are at least 70½, you may want to consider making a charitable donation through a Qualified Charitable Distribution (QCD). You can make a QCD directly to Skagitonians to Preserve Farmland without the gift counting as income for federal income tax purposes. Contact your IRA plan provider to learn their procedures.

### STOCKS, BONDS & MUTUAL FUNDS

Donating stocks, bonds, and mutual funds can be an easy way to give to Skagitonians to Preserve Farmland. If itemizing, you'll generally take a tax deduction for their full fair market value. Please contact the SPF office for forms you can give your broker.

# KEY ACCOMPLISHMENTS



Convened and hosted Washington State Department of Agriculture (WSDA) Director Derrick Sandison, Puget Sound Partnership (PSP) Director Laura Blackmore, PSP Leadership Council President Jay Manning and PSP Leadership Council members Dennis McLaren and Jim Wilcox, to meet with Skagit agricultural leaders on issues related to farmland preservation and Chinook recovery.



Successfully lead a public campaign to stop a Skagit County Comprehensive Plan Amendment that would have allowed the advancement of the Avalon Fully Contained Community, the highest density development ever proposed for unincorporated Skagit County with over 4,000 homes and commercial businesses sprawled onto 585 acres of land.



Convened an Agriculture Water Roundtable with State Representative Debra Lekanoff and Skagit agricultural irrigators to discuss and explore the complex issues related to the long-term sustainable use of water and agriculture.



Worked with Skagit County Conservation District, the Board of County Commissioners and the local agricultural community to find balance for a Special Assessment that could support the Skagit Conservation District's ongoing work at taxing rate agricultural landowners could financially support.


